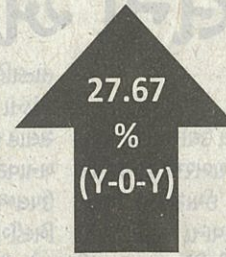

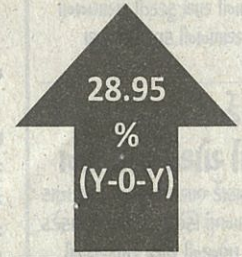
Sales Growth
