

Scrutinizers Report on Postal Ballot (E.voting) Process conducted by the Company for the period from 22/12/2023 to 20/01/2024. (Record Date for ROM 08/12/2023).

Dear Sir,

I, Kamlesh M. Shah, proprietor of M/s. Kamlesh M. Shah & Co., Practicing Company Secretaries, having office at 801-A, 8<sup>th</sup> Floor, Mahalay Complex, Opp. Choice Restaurant Lane, B/h. Fairdeal House, off. C. G. Road, Navrangpura, Ahmedabad-380009, Gujarat, India have been appointed as a scrutinizer by the board of directors of Arfin India Limited ("the Company") vide resolution dated 25<sup>th</sup> November 2023 for the purpose of scrutinizing the process of voting through electronic means on the resolution contained in the Postal Ballot Notice issued on 25<sup>th</sup> November 2023.

The said appointment as Scrutinizer is under the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended. As the Scrutinizer, I have to scrutinize:

(i) process of e-voting remotely, using an electronic voting system on the dates referred to in the Postal Ballot Notice dated 25<sup>th</sup> November 2023.

The Compliance with the provisions of the Companies Act, 2013 and the Rules made thereunder, MCA Circulars and SEBI (Listing Obligations and Disclosure Requirement) Regulations, 2015 relating to voting through electronic means (by remote e-voting on the resolution proposed in the Postal Ballot Notice is the responsibility of the management. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems. Our responsibility as scrutinizer for e-voting process is restricted to making a Scrutinizer's Report of the votes cast "in favour" or applied for any, on the resolution contained in

the notice, based on the reports generated from the electronic voting system provided by National Securities Depository Limited (NSDL) and documents furnished to me by the Company and / or NSDL for my verification. I submit my report as under:

- The remote e-voting period commenced from 9.00 a.m. (IST) on Friday, December 22, 2023 and concluded at 5.00 p.m. (IST) on Saturday the 20<sup>th</sup> January 2023. The remote evoting services were provided by the National Securities Depository Limited (NSDL) evoting division.
- 2. The shareholders holding shares as on the "cut-off date" i.e. Friday, December 8, 2023 were entitled to vote electronically on the proposed resolution stated in the Postal Ballot Notice of the company dated 25<sup>th</sup> November 2023.
- **3.** As per the Postal Ballot Notice, the Remote E.voting period commenced on Friday 22<sup>nd</sup> December 2023 at 09:00 A.M. and was concluded on Saturday the 20<sup>th</sup> The January 2024.
- 4. After closure of e-voting, the votes cast through e-voting were unblocked on January 22, 2024 at 12.35 P.M. and downloaded from the e-voting website of National Securities Depository Limited (<a href="https://www.evoting.nsdl.com">https://www.evoting.nsdl.com</a>) in the presence of two witnesses Mr. Anish Vinodchandra Shah and Mr. Praful Lavantra, who are not in the employment of the company. The e-voting data / results downloaded from the e-voting system of NSDL were scrutinized and reviewed, the votes were counted, and the results were prepared.
